### **Incorporation Process**

#### **Select the company name for your Company**

▶ You should use a unique company name that is not either identical or deceptively similar to one that is already used by another company.

#### **Choose your business structure**

▶ The primary company structures incorporated are Private Limited Companies. Sometimes there are company types, specific to different countries such as the LLC or the IBC.

#### **Select a Registered Office**

▶ You must select a registered office for your company. This must be in the country of incorporation. We can provide a registered office facility for your company if required.

#### **Select Shareholders**

▶ You must select who will be the shareholders of your company.

#### **Number of Shares**

▶ The issued share capital is the number of shares you would like to make available to the shareholders in your company.

#### **Select Directors**

▶ You must decide who will be the directors of your company. Directors are the individuals who administer the affairs of the company and make all major decisions.

#### **Accounting Year-end**

➤ You must select the fiscal year-end of the company.

### Select Accountants

➤ You may select the auditors or accountants of your company.
